4. Proprietor's Additional Remuneration

- 4.1 If the Horse, or Interest or Share in the Horse, is being sold, and:
- the Horse is being trained by the Proprietor; or
 - the Horse is sold within 90 days after ceasing to be trained by the Proprietor; or
 - the Horse won a Group 1, Group 2, Group 3, Listed or Restricted Listed race while being trained by the Proprietor;
- ...the Proprietor may opt to invoice an amount not exceeding 5% plus GST of any proceeds of sale (ex GST) after deduction of expenses directly relating thereto including any commission paid to third parties.
- 4.2 If the Horse, or Interest or Share in the Horse, is being sold, and:
- the Proprietor acted as Buying Agent of the Owner to originally select and purchase the Horse; or
 - the Proprietor acted as Selling Agent of the Owner and sourced a Buyer for the sale of the Horse and that Buyer successfully purchased the Horse;
- ...the Proprietor may opt to invoice an additional amount not exceeding 5% plus GST of the proceeds of sale (ex GST) after deduction of expenses directly relating thereto including any commission paid to third parties.
- 4.3 If the Horse is an Entire and retired to Stud, and:
- the Horse is being trained by the Proprietor; or
 - the Horse is retired within 90 days after ceasing to be trained by the Proprietor; or
 - the Horse won a Group 1, Group 2, Group 3, Listed or Restricted Listed race while being trained by the Proprietor;
- ...the Proprietor may opt to enforce in any sale contract the entitlement of one (1) transferable Lifetime Service right entitling the holder of such right to nominate a mare to be provided with a stud service by the Horse during each season that the Horse is used to provide stud services commercially, free of any service fee.
